Founders' Day Celebration - April 6, 2019

April 5, 1851 is the historical date of the founding of San Luis. But as with most of our history, dates are muddled. At least five villages: Manzanares (now Garcia), San Acacio, Colonias, San Pedro, and San Francisco all had a square (plaza) before San Luis did. Communities on the Sangre de Cristo Land Grant in what is now Colorado were being built since probably 1847. Be that as it may, the official first town of Colorado was settled on paper on April 5, 1851. And so we will celebrate Founders' Day on April 6th.

The names of the Founders are being collected by Maria Clara Martinez who is publishing a book, *The Founding Families of San Luis de la Culebra*. She is listing families who are found in the New Mexico census of 1850 as living in the Culebra region of Arroyo Hondo, in the 1860 census of New Mexico in Culebra—remember that none of this belonged to Colorado until it became a territory in 1861. For the purposes of this celebration, any family here before Colorado became a territory will be honored.

Founders' Day Celebration on April 6th begins with a Pancake Breakfast at the Parish Hall hosted by the Centennial School Student Council as a fundraiser at 9:00 a.m. Tickets and Menu information were not available at the time of this publication.

A Color Blaze 5K Run/Walk is

slated to get started at 10:00 a.m. for runners and 11:00 a.m. for walkers at the south entrance to the Vega on Highway 159.

Historical Tour of Main Street begins at 10 a.m. The current tour includes 11 historical sites. Maps will be available for people to take individual tours at their leisure. There will be at least three free guided tours beginning at 10:00, 10:15, and 10:30 a.m. beginning at the Parish Hall Parking Lot.

At 11:00 a.m. Founders' Descendants Certificates will be awarded to Students, whose genealogical pedigree traces their heritage to one of the founders.

From Noon to 6:00 p.m. there will be live music. Vendor booths will feature local food and crafts. Vendors interested in having a booth are asked to contact Adelante San Luis at adelante624@gmail.com or 719-214-2548. A \$25 space-saver deposit for a booth space is required. The deposit is returnable to the vendor if they actually set up a booth. If selling food it is required that the vendor contact Adelante San Luis and let them know what is being sold so as to prevent duplicated efforts.

From 6:00 to 8:00 p.m. a bonfire with DJ is slated for area behind the Parish Hall. All events will be outdoors in the Parish Hall Parking Lot weather permitting. If not, the event will be held indoors at the Parish Hall.

Be in the Know! Dangerous Dogs

The Town of San Luis is currently working on a Dangerous Dog Ordinance to add to the San Luis Municipal Code in coming months. The Town has experienced several instances of dogs killing other dogs over the recent months.

For the safety of its' citizens, the Town will have owners of dangerous dogs cited into court when their dog causes a physical threat by injury or death to another domestic animal or person. This will also include dogs that menacingly approach anyone walking through the streets of their neighborhood.

If you have been approached by a dog and feel threatened by its behavior, it is very important that you immediately file a report at the Town Hall. The Town can not follow up on dog issue unless a formal letter of complaint is issued. If the threat is serious it is also important to file a report with the Sheriff's Office as well.

The following is just part of the new dangerous dog ordinance the Board of Trustees is working to add to the San Luis Muncipal Code.

A person commits the crime of ownership of a dangerous dog if such person owns, possesses, harbors, keeps or has custody and control over a dangerous dog, within the Town of San Luis, that:

1. Inflicts or causes bodily injury or serious bodily injury upon a domestic animal or causes the death of a domestic animal.
2. Has been determined by a court of record within the State of Colorado to be a vicious or dangerous dog and does not comply with the conditions imposed by applicable law for ownership of the animal.
3. Engages in or has been trained for dog fighting as described and prohibited in Section 18-9-204, of the Colorado Revised Statues (C.R.S).
4. Approaches any person, without provocation in a menacing manner, whether or not an attack actually occurs; or
5. In an attacking manner encroaches over, through or under a fence onto public or private property; or
6. Inflicts a puncture wound,

abrasion, or other wound caused by the dog's teeth upon a person or a domestic animal which injury does not meet the definition of bodily injury or serious bodily injury.

Penalties:

Any owner convicted of a violation of this Section shall be subject to the general penalty provided in Section 1.09.020 of the SLMC. In addition, the Costilla County Court or San Luis Municipal Court may order any owner of a dangerous dog who has been convicted of a violation of this Section to:

1. Confine such dangerous dog in a building or enclosure designed to be escape-proof and, whenever such dog is outside of such building or enclosure, keep the dog under such owner's control by use of a leash.
2. In addition to any other penalty set forth in this Subsection, upon an owner's entry of a guilty plea, the return of a verdict of guilty by the San Luis Municipal Judge or Costilla County Judge or a jury, or a deferred judgment or deferred prosecution for a violation that results in bodily injury, serious bodily injury or death to a person or domestic animal, the San Luis Municipal Court or Costilla County Court, pursuant to applicable provisions of Title 16 of the C.R.S., governing restitution, may order the defendant to make restitution in accordance with said provisions.
