What You Need to Know Before Voting on Amendment 74

You will be making an important decision on November 6. Amendment 74 will subject your hometown to unprecedented levels of legal exposure at the cost of the public's expense.

Amendment 74 is financed by certain out-of-state interests as a state constitutional amendment to strengthen "private property rights."

Amendment 74 is a thinly veiled attempt to protect special-interest profits at the expense of everyday Coloradans.

Amendment 74 will diminish your city or town's ability to provide basic services residents depend on at the taxpayers' expense.

Amendment 74 will undermine the ability of local governments to protect their residents and communities in vital areas such as: public

safety and crime reduction; clean air and water; preserving neighborhood integrity; transportation, sewer maintenance, and other critical infrastructure; trash collection; parks, recreation centers, and other neighborhood amenities.

IF amendment 74 passes, it will: hold your community liable simply for operating in the public interest; increase lawsuits and costly litigation—all financed by you, the taxpayer; increase the cost of government while simultaneously reducing essential municipal services; decrease the quality of life for all Coloradans—for the benefit of out-of-state special interests. And these are just a few examples of the implications.

Removal of Trees and Limbs from Public Right-of-Way

As stated in the San Luis Municipal Code, Section 7-6-20, it is the responsibility of property owners who own land adjacent to the public right-of-way to remove any trees or limbs located in or above the public right-of-way when such trees or limbs constitute a danger to public safety. Including trees and bushes that block the view of traffic and the view of stop signs, speed signs and other public road signs. Also, removal of trees and limbs which present a structural defect which may cause the tree or limb to fall on a person or on a property of value is included in this ordinance.

Please review your property to make sure your trees, shrubs and bushes are not obstructing traffic signs. If so, please trim back the foliage that is obstructing the sign. Lack of proper care of those trees, shrubs and bushes in the right-of-way are considered a nuisance and will be subject to Code Enforcement regulations and could result in possible fines.

Using Residential Property as a Junkyard

As stated in the San Luis Municipal Code, Section 7-2-160, All places within the town limits of San Luis, that are used or maintained as junkyards or dumping grounds, for the wrecking or disassembling of automobiles, trucks, tractors or machinery of any kinds, for the storing or leaving of worn out, unlicensed or uninsured wrecked or non-drivable automobiles, trucks, tractors, trailers, RVs, boats and house trailers, appliances or machinery of any kind, or of any parts thereof, or for the storing or leaving of any of the above machinery, which interferes with the comfortable enjoyment of life or property is declared to be nuisances.

If your property has any of the above you are in non-compliance of ordinance Section 7-2-160. Please review your property ASAP and remove any and all of items as stated above. Non-compliance of this can result in, fines and possible court judgments. For questions please visit or call Town Hall, 672-3321.



TOWN CLEAN-UP DAYS

The Town of San Luis is sponsoring Fall Dumpster Days on November 9, 10 & 11 for town residents to have a place to remove trash, branches, piles of wood and other rubbish from their yards. The dumpster will be on first come, first served basis and closed once the dumpster is full. Common household trash will not be allowed for dumping. This service free of charge.

San Luis Community Park Recreation Center

The Town of San Luis Board of Trustees is working diligently to find a way to build a Recreation Center on the Town's park property on 6th and Main Street. In past years, several attempts have been made to make the recreation center a reality. The biggest issue facing the town is sustainability. How will the day-to-day operation cost of the recreation center be met?

One of the options is to create a separate recreation district which would include raising the Mill Levy (raising local taxes) to cover the cost. This measure was attempted back in the 1990s and the measure did not pass. Understandably, folks don't want higher taxes. The question is--should this be attempted again?

The town is looking for citizen feedback on this subject. In the near future, the Town of San Luis is hoping to team up with other local agencies to help solve this problem. Currently, no formal agreements have been made with other agencies. The town is inviting citizens and local agencies to formally partner with the Town to solve this problem. To date, the Town is the only organization focused on this issue.

Be sure and join us on Friday, November 9th, 2018 at 6:30 pm at

the Town Hall to review and discuss the second phase of the Feasibility Study to build a Recreation Center in the Town of San Luis. The Town of San Luis, through a grant from the Colorado Department of Local Affairs, has contracted with the University of Colorado's University Technical Assistance Field Supervisor, Jeff Woods, and students from the Colorado Center for Community Development, University of Colorado Denver, College of Architecture and Planning to help the Town of San Luis create a plan to make the Recreation Center a reality for its citizens.

The first phase meeting was held August 9th, 2018 at the Centennial School, where around 30 citizens showed up to discuss the best placement of the Recreation Center. The consensus was, the Recreation Center would best serve the community at the San Luis Community Park on 6th and Main Street. Armed with that information, Jeff Woods, and his team of students, went to work on creating schematics of how the Recreation Center would fit and work on the San Luis Community Park Property.
