Support the San Luis Community Park

The Town of San Luis is applying for a grant for \$142,000 from the Colorado Health Foundation (CHF) to seek funding to expand the San Luis Community Park. The goal is to add a quarter-mile walking and biking path around the park plus a children's bike playground next to the Kaboom playground.

To complete the project, the

Town will need to raise \$35,000 in matching funds. The Town would like to ask town citizens to show their support by donating any amount, large or small, to the Town Park fund. Your donation to the Park Fund will show the CHF that citizens support this project. To donate come into the Town Hall during regular business hours.

San Luis Valley Rural Philanthropy Days

The Town of San Luis was represented by Town Manager Susan Sanderford at the the San Luis Valley Rural Philanthropy Days (RPD) in Del Norte from September 17th to 19th, 2019.

This conference was attended by 250 San Luis Valley nonprofit professionals, grantmakers, community leaders, and elected officials to exchange knowledge and expand professional fundraising networks.

Rural Philanthropy Days is a statewide program that promotes excellence in Colorado’s rural communities by providing nonprofit leaders access to resources they need to make a stronger impact. RPD builds opportunities for important community projects within the San Luis Valley and across the state by strengthening regional relationship, building the skills of the region’s nonprofits, and connecting local organizations with grantmaking organizations.

This conference provided a powerful opportunity for the state’s



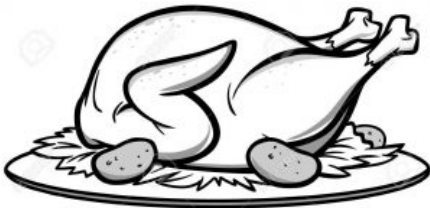

most influential funders to meet one-on-one with local and regional grantseekers in a series of funder roundtable discussions. This exchange helps to break down barriers and ultimately results in stronger partnerships, increased

access to resources and the development of long-term relationships. Through her RPD efforts, Ms. Sanderford was able to secure green lights to submit grants to four Colorado funders to help expand the San Luis Community Park.

The Town of San Luis is sponsoring Fall Dumpster Days for town residents on November 9th and 10th, 2019 from 8 am to 5 pm to have a place to remove trash, branches, piles of wood and other rubbish from their yards.

The dumpster will be placed at the Town Shop on the south end of town for residents to bring and dis-

pose of their yard trash.

We would like all residents to make a concerted effort in cleaning up dried brush, wood and rubbish from their yards as a safety measure to prevent future fires. We are offering this service free of charge. The dumpster will be on first come, first served bases and closed once the dumpster is full.

Common household trash will not be allowed for dumping. No furniture or appliances allowed. NO TIRES allowed. This service is available for Town residents only. The dumpster will be monitored. Helping community members with affordable housing in the Valley since 1993

The mission of the SLVHC is to provide safe and affordable housing to low-to-moderate income community members. The SLVHC addresses the increasing housing needs of the San Luis Valley through two programs that it offers: Down Payment Assistance Program and Home Rehabilitation Program.

The San Luis Valley Housing Coalition designed the Home Rehabilitation Program to help qualified low-to-moderate income home-

owners make the necessary repairs to their home. In order to bring about a safer, more sanitary and energy efficient living environment. SLVHC offers this loan program at a low-interest rate, 1-5%, which can be amortized up to thirty years. Affordable monthly payments may be tailored to suit your particular financial situation. Your monthly payments to the SLVHC will be deposited into a Revolving Loan Fund so that others in need of rehabilitation may receive assistance.

There are eligibility criteria to qualify for the Home Rehabilitation Program, you must meet minimum requirements of owning your home and live in it as your primary residence. Your home must be located within Alamosa, Conejos, Costilla, Mineral, Rio Grande, and Saguache Counties. Your household income must not exceed the Program Income Limits for your household size found on the slvhc.

com website.

With the Down Payment Assistance Program, qualified low to moderate income home buyers can get a low-interest loan for the down payment of their home. These loans cover the down payment and closing costs and come with a minimal interest rate. The San Luis Valley Housing Coalition offers these loans so that community members may live in safe, affordable homes and can still afford to live.

Your loan will be secured by a Deed of Trust against your home. The monthly payments you make are deposited into a Revolving Loan fund so that others may benefit from the program as well.

Cat's Alive Voucher Program

Cat's Alive and the Town of San Luis have partnered to help residents have a low-cost way of spaying or neutering their cat. The Town has 10 vouchers for the cost of \$20 to take your cat to Dr. Deal in Monte Vista for spaying or neutering. These vouchers can save you over \$100 depending on whether you have a male or female cat. Just come in to Town Hall to pick up a Cat's Alive Voucher.

If you want to know when and where the next Free Spay/Neuter Clinic will be set up, join the Facebook group called SLV FREE OR LOW COST SPAY NEUTER CLINICS. Once there read the posts and click the link that allows you to sign up for the next clinic—there may be a series of questions you will need to answer. These clinics require same day drop off and pick up, usually after 5:00 pm. Your pet must be 4-months-old or older to be eligible to receive a Rabies shot.

If you cannot make any of the free clinics, designate a friend or family member to bring in your pet(s) for you. They can sign the consent form as your agent.
